ELIGIBILITY

PGDM

Specialization

Finance, Marketing, HR, Operations, Entrepreneurship Management and Business Analytics

Bachelor's degree in any discipline from a recognized University with minimum 50% marks in aggregate or equivalent grade.

PGDM (Pharmaceutical Management)

Bachelor's degree in Pharmacy, Medicine, Biology, Chemistry and other Life Sciences with minimum 50% marks in aggregate or equivalent grade.



Applicants appearing for final year degree examination can also apply. However, if selected, they will have to produce the proof of completion of their graduation with minimum 50% marks before 31^{st} October, 2023, failing which their admission will be cancelled and the entire fees paid by them will be forfeited.

Applicants having backlog of subjects or ATKTs, which are not cleared till 31st March 2023 are not eligible for admission. Similarly, those who did not clear their SSC and HSC examinations in first attempt are also not eligible for admission.



2 APTITUDE TEST

Applicants who have appeared in at least one of the following written aptitude tests are eligible to apply.

☑ CAT ☑ CMAT ☑ ATMA ☑ GMAT ☑ MAH-CET

Applicants must submit the documentary proof / evidence for the aptitude test score which they mention in the application form. If candidates have not received the test score till the time of submitting the application form, then they should submit the photocopy of their score card at the time of Personal Interview (PI).

Applicants should mention scores of all the tests they have appeared for. IES MCRC will consider the highest score among all the tests which the applicant has provided in the application form.

Note: IIMs or any other agency conducting the above tests have no role in the selection process of IES MCRC.

ADMISSION PROCESSING FEES AND PAYMENT OPTIONS

- A. The admission processing charges for PGDM program is INR.2000/-
- B. The admission processing charges can be paid online (credit/debit card/NetBanking) or offline (DD/NEFT).
- C. Applicants will be given access to the online application form upon confirmation of the payment.
- D. The application will be considered as accepted on completion of entire application form.
- E. If the applicants choose to pay by Demand Draft or Online Money Transfer (NEFT), they should provide the DD number in case of Demand Draft or UTR number in case of NEFT and enter the details while making the offline payment. After submitting the details 'Payment Confirmation Form' will be generated.

- If the payment is made using demand draft, the applicants should take the printout of the 'Payment Confirmation Form' and send it to the College address (along with DD within 3 working days)

MANDATORY DOCUMENTS

All the applicants who get shortlisted for participating in the selection process are advised to submit one set of self-attested documents as per the following sequence at the time of Personal Interview (PI).

- A. 10th, 12th, and Degree (Semester / Year wise) Mark Sheets and Certificate.
- B. Aptitude Test (GMAT / CAT / MAT / XAT / ATMA / CMAT / MH-CET) Score Card, whichever is applicable.
- C. Work Experience Certificate (if any)
- D. "Gap Affidavit" (Period after Graduation till Admission Date), if applicable
- E. Photographs 2 Nos. Stamp Size (Please write Name on the reverse side of the photograph along with the Registration No.)
- F. Aadhaar Card

The shortlisted applicants must bring the original certificates for verification at the time of Personal Interview (PI) / while finalizing the admission.

Details:

INR 2,00,000/- waiver in the first year tuition fees for the Top 5 candidates in the IESMCRC Merit List provided they score minimum 85 percentile in the written aptitude test required for the admission (CAT, MAT etc.).

The fee waiver will continue for the second year, provided the student:

- a) Scores average 75% marks in the first year.
- b) Has overall good performance in co-curricular and extra-curricular activities (internal and external activities).
- c) Maintains highest standards of adherence to the General Code of Conduct described in the handbook and shouldn't have any instance of misbehavior / indiscipline.

Up to INR 1,50,000/- waiver in the first year tuition fees for the Top 3 candidates in the IES MCRC Merit List

TUITION FEES WAIVER QUOTA (TFW)

Applications are invited for admission into PGDM (10 Seats) / PGDM-Pharmaceutical Management (2 Seats) under Tuition Fees Waiver Quota (TFW quota) from eligible candidates for academic year 2023-24.

Eligibility and Requirements:

- A. Sons/Daughters of parents whose annual income from all sources shall NOT exceed INR 8 Lakhs.
- B. The Waiver is limited to the Tuition Fee as approved by the BOG of the Institution.
- C. All other Fees except Tuition Fee shall have to be paid by the beneficiary.
- D. Academic eligibility for admission remains same as that applicable for open category candidates. (Certificate from the competent authority should be emailed along with the other academic documents to admissions@ies.edu, after submitting the Online Application through the College Website)



CANCELLATION OF ADMISSION

For any reason if an applicant decides to cancel admission after payment of fees, then the refund will be as per AICTE rules.
